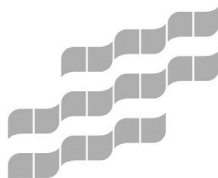

The client fees for municipal early childhood education and the own deductible part of the service voucher are based on the Act on Client Fees in Early Childhood Education and Care (1503/2016). The client fee is determined by the size of the family, the need for service as well the gross income. New clients must fill in the client fee form and submit the required appendices to the Client fees of Early childhood education within a month from when the care started at the latest.

The income statement is not needed if the family agrees to pay the highest fee.
