Management of the application's voluntary login information and implementation of the mobility carbon footprint calculator service in accordance with the application's terms of use.

Optional credentials allow to individually manage app views and transfer your own settings as your mobile device changes. The anonymised location and travel data of the mobility carbon footprint calculator is utilized in statistical surveys, in the development of the city's services and for other purposes of general interest in accordance with the terms of use of the service.

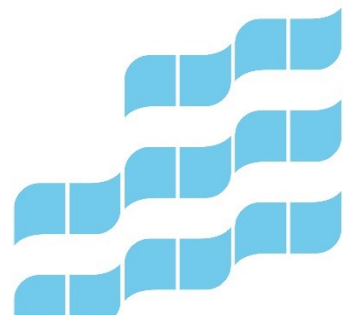

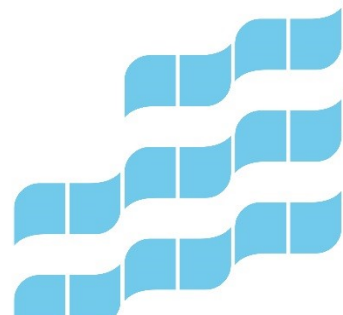

7. Personal data in the register

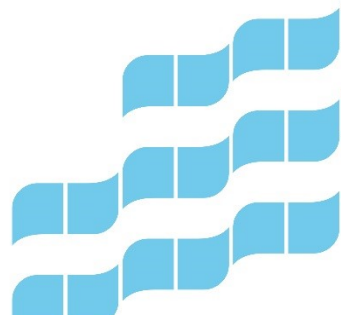
The e-mail address provided by the user during the voluntary login. For the carbon footprint calculator, anonymized location information collected from the user's mobile device to implement the service.

8. Maintenance systems of the information in the register

The login data is stored in a secure system with limited access by Hion Oy. The anonymized data of the carbon footprint calculator is stored in a secure system with limited access by Codemen Oy. The data in these two separate systems cannot be combined. The data is processed only by the persons whose duties it involves. The servers are located in the EEA.

10. Data sources of the register

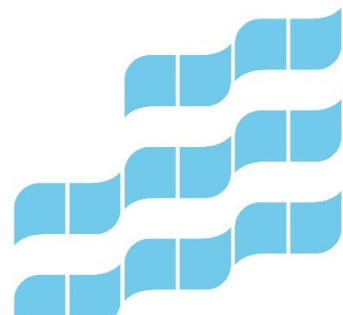

The consent given is valid until further notice. Consent can be revoked for login information (e-mail address) by selecting Delete from the application settings, after which the collected data will be permanently and irrevocably deleted. Anonymized location data collected by the carbon footprint calculator is automatically deleted three days after it is collected. All data in the carbon footprint calculator can be deleted by selecting Delete Data from the application settings. If the carbon footprint calculator is not used for more than 6 months, all data will be deleted automatically. You can stop collecting anonymous location data by disabling the calculator in the application settings.
