

# LOCATION CARD

## Kalevan Halli, 3 spaces

The meanwhile use space is Kalevan Hall, located at Sarvijaakonkatu 28, which is a repair hall. In this search, three smaller workspaces are available from Kalevan Hall. The environment around Kalevan Hall is planned for other communal activities for the coming year, so interest in joint activities is considered an advantage for the applicant. The space is an industrial hall and has previously operated as a car repair shop. Additionally, the space includes office and social facilities. The social facilities are shared with other operators. The large hall space and other areas of the repair shop have other activities and through traffic.

The spaces marked in red on the floor plan are also handed over for use, and they are suitable, for example, as artistic workspaces. In other hall spaces, it is possible to organize workshops by separate agreement with other operators.

**Space 1 ("TILA 1" in picture) consists of two rooms, and their size is approximately 16 m<sup>2</sup>.**

**Space 2 ("TILA 2" in picture) consists of two rooms, and their size is approximately 19 m<sup>2</sup>.**

**Space 3 ("TILA 3" in picture) is a room with a partition wall in the middle of the room. Its size is approximately 23 m<sup>2</sup>.**

The spaces are handed over in their current condition and must be returned in usable condition. Light structures can be built in the hall space without damaging the building, and it can be painted inside and outside. Plans must be approved by the city upon commissioning.

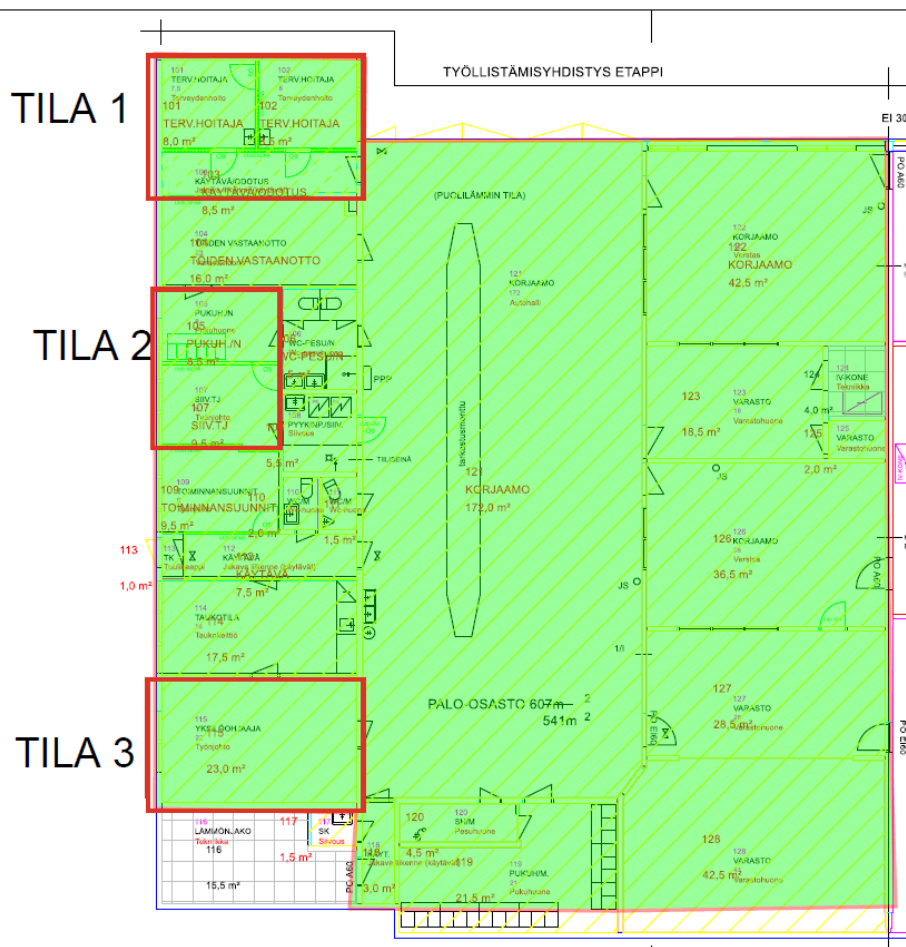

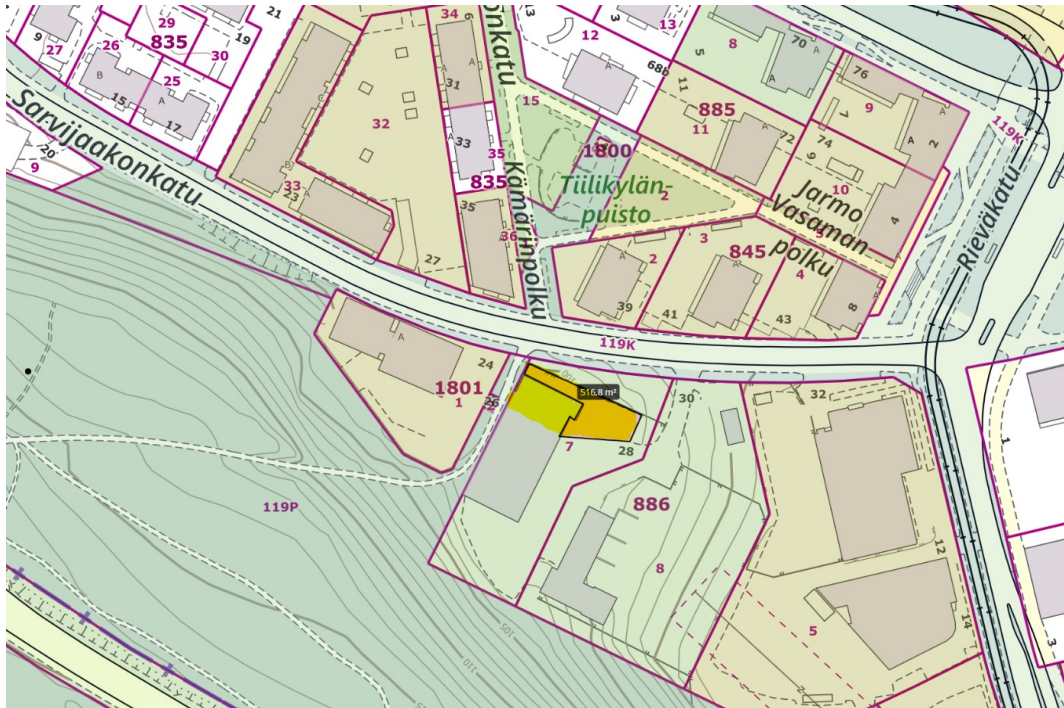
**Floor plan: Spaces marked in red for use (TILA 1.-3.)**
