Grounds for processing the application

Waste management services may be suspended for a limited period if the **residential building is completely unused**. The suspension applies to all types of waste for which the waste management is required by waste management regulations.

Suspensions of up to one year are agreed with Pirkanmaan Jätehuolto. Suspensions of more than one year require an exemption from the waste management regulations, when you must make an application to the waste management authority.

The suspension is granted for a limited period of up to four (4) years at a time. During the suspension, the property holder will be charged an annual basic charge for a holiday home.

If a residential building is unusable, the waste management connection obligation and the basic charge may be removed for a limited period. In this case, proof of the building's unusable condition must be attached to the application. Proof can be an statement from an expert (e.g. a construction professional, municipal building control or housing health expert) or photographs that clearly show the condition of the building.

The decision will be sent to the applicant in writing and forwarded to Pirkanmaan Jätehuolto and the environmental protection authority of the municipality where the property is located.
